**The Food Hygiene (Amendment) Regulations (Northern Ireland) 2010**

*Made* - - - -

*1st March 2010*

*Coming into operation-* -

*13th April 2010*

The Department of Health, Social Services and Public Safety(**a**) makes the following Regulations in exercise of the powers conferred on it by section 2(2) of the European Communities Act 1972(**b**).

The Department of Health, Social Services and Public Safety has been designated for the purposes of that section in relation to measures relating to food (including drink) including the primary production of food(**c**).

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(**d**) there has been open and transparent public consultation during the preparation of the following Regulations.

**Citation, commencement and interpretation**

**1.**—(1) These Regulations may be cited as the Food Hygiene (Amendment) Regulations (Northern Ireland) 2010 and come into operation on 13<sup>th</sup> April 2010.

(2) The Interpretation Act (Northern Ireland) 1954(**e**) shall apply to these Regulations as it applies to an Act of the Northern Ireland Assembly.

**Amendments to the Food Hygiene Regulations (Northern Ireland) 2006**

**2.**—(1) The Food Hygiene Regulations (Northern Ireland) 2006(**f**) are amended in accordance with paragraphs (2) and (3).

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Food Hygiene Regulations (Northern Ireland) 2006 (S.R. 2006 No. 3, as already amended)

These Regulations amend the Food Hygiene Regulations (Northern Ireland) 2006 to update the definitions of certain EU instruments by—

- (a) substituting references to specified EU instruments for the references to the EU instruments that currently appear after the definition of “the Community Regulations” in regulation 2(1) (interpretation) (*regulation 2(2)*); and
- (b) substituting a revised Schedule 1 (definitions of EU legislation) for the existing Schedule 1 (definitions of Community legislation) (*regulation 2(3)*).
