## Additional information: Response to FOI request AFBIFOI20230501

Thank you again for your email of 02 May 2023 where you requested information about grievance and recruitment management within AFBI. I am writing to advise that the Institute has completed its search and can confirm that we hold information relating to most elements of your request.

This letter uses initialisms as shorthand for the larger AFBI organizational structures known as divisions. These are Finance and Corporate Affairs Division (FCAD), Environment and Marine Science Division (EMSD), Sustainable Agri-Food Science Division (SAFSD) and Veterinary Science Division (VSD).
